Richard, Steve and Andy to meet with Dr Paul Miller at Talis on 31st Oct to share information. Richard also discussed the Science Commons - Data Licence and pointed out that this

		appears to be directed at the academic community and was not a viral / attribution type licence. Steve confirmed that Multimap have taken legal advise relating to their possible use of OSM data and that the advise is that they should not do so. A written response is awaited from Multimap in order to understand the advise given. Mikel reported that he and Cory had met in Victoria, Canada and that Cory had brought up two questions/concerns received from
		a lawyer working on the Cairo project. These relate to the use of the Yahoo imagery. Mikel to follow up with Yahoo.
