Subject: entry in the Provincial Register of Nonprofit Associations - Section F - Associations for Social Promotion - of "WIKIMEDIA ITALIA - Associazione per la diffusione della conoscenza libera" (TRANSLATOR NOTE: in english: "WIKIMEDIA ITALIA - Association for the advancement of free knowledge")

THE WELFARE, EDUCATION, EMPLOYMENT AND TRAINING, PRODUCTIVE ACTIVITIES DIRECTOR

Referring to:

- the Consolidation Act of regional laws in the field of volunteering, social cooperation, associations and mutual aid society, Regional Law #1 - 14/02/2008 (ex r.l. 16 September 1998, #28 "Promotion, acknowledgement and advancement of the associations");
- the Regional Law #3 - 12/03/2008 "Government Network of Interventions and Personal Social and Healthcare Services", which in the clause n. 12, letter c), confirms the Provinces care of keeping the *Provincial Register of Associations*, referred to *Chapter III* of the Regional Law n. 1 of 14/02/2008;

Having regard to the legislation on the Nonprofit Associations:

- the deliberation of the Regional Council n. VI/625 of 5 July 1997 "Resolutions concerning the implementation of provisions referred to the r. l. 16 September 1996, n. 28 "Promotion, acknowledgement and advancement of the associations";
- the Regional circular #36 - 10 July 1997 of the Directorate-General for Social Measures "Procedures and compliances for entry in the Regional and Provincial Register of Associations pursuant to r.l. n. 28/96";
- the Decree n. 3082/97 of 15 June 1998 of the Directorate-General for Social Measures of the Lombardy Region by which the "Provincial Registers of Nonprofit Associations" were activated, with effect from 15 July 1998;

Having regard, in particular, the specific legislation of Associations for Social Promotion (APS):

- the Law of 7 December 2000 n. 383 "Discipline on the Associations for Social Promotion" which lays down basic principles and rules on the development of associations for social promotion;
- the Regional Law of 24 February 2006, n.5 "Dispositions in field of personal and community services" which made changes to r.l. 16 September 1996, n. 28 "Promotion, acknowledgement and advancement of the associations", and in particular introduced the idea of social promotion in the r.l. 28/96, under the Law 383/2000, and instituted a specific section for the association for social promotion in the context of regional and provincial registers;
- the explanatory note of the Directorate-General for Family and Social Solidarity of 25 July 2006, which identified the technical operational requirements concerning the entry in the regional and provincial registers of associations.

Having regard the decision of the Regional Council n. 30/2009, provincial acts n. 4575/2009/13.2/2009/1, whose object is “Start of the functions concerning the regional register of voluntary organisations, Monza-Brianza provincial section, and the provincial register of nonprofit associations, operating on the territory of the Monza-Brianza province”;

Considering the request for inclusion in the “Provincial Register of Nonprofit Associations - Associations for Social Promotion (ASP) section”, lodged on 3 September 2009 provincial protocol n. 3179 by the President of the Association “WIKIMEDIA ITALIA - Associazione per la diffusione della conoscenza libera”, located in Arcore, Via Del Ronco, 3/A - TAX CODE 94039910156;

Noting that the documentation provided complies with the requirements of the Regional Law n. 1/08 and of the Regional Law n. 5/06;

Having regard

- the Legislative Decree 267/200 as subsequently amended and supplemented
- the articles 28 and 30 in the Statute of the Monza-Brianza Province on the assignment of managing and the identification of the legal business within their competence;

Decrees

1. The entry in the “Provincial Register of Associations, ASP section” at the n. MB - 12 of the Association “WIKIMEDIA ITALIA - Associazione per la diffusione della conoscenza libera”, located in Arcore, Via Del Ronco, 3/A - TAX CODE 94039910156
2. To notify the Association, the Lombardy Region, the Arcore Mayor, all interested to the knowledge of the registration, about this measure.
